To Certify or Not Certify – Is That a Question?

Raise your hand if you remember thinking as a child, "I want to grow up and be a Medical Staff Professional." I am not visualizing many hands

raised, and that was not my experience either. I do have memories from when I was 3 years old of playing "meeting" with my stuffed animals. I distributed agendas, food and expected each one in attendance to contribute to the best of their ability. Perhaps this was all foreshadowing of my future career. At sixteen, I announced that I wanted to be an attorney, to which my father replied, "That's ridiculous you need to get a woman's job." I begrudgingly entered into secretarial training, never imagining that it would be the springboard for an amazing career as a Certified Medical Staff Professional. Fast forward to today, I am still distributing agendas. I get to dabble in legal issues. I care for my real committee members, just as I did the stuffed ones of my childhood.

As our recent speaker, Yvette Scott, CPMSM, CPCS, outlined, this profession has evolved since the early-70's and our opportunities within the profession have grown. Being goal oriented, once I learned that there was a certification opportunity, whether to attain it was not a question for me. However, the decision may not come as easily to some for a variety of reasons.

Currently there are 31 Certified Medical Staff Professionals, 4 of whom are dual certified, within our state association. This is just over half of our MAMSS membership. Congratulations to all who have already chosen certification or are in the process of preparing for the examination. For those that are still on the fence, let's review the barriers and possible ways to address them:

- **Test Anxiety/Fear of Failure** – Keep in mind that there is no shame in attempting this examination more than one time. One tip is to go in with the mindset that your first exam is for the experience, for practice. This can eliminate a lot of the pressure you may be putting on yourself. Deep breathing, visualization techniques and good preparation may also help to resolve some of the anxiety.
- **Financial** - The cost of the examination is not inexpensive. However, if you plan for it a year in advance, and set aside \$8 a week, you will have saved enough to take the examination and maybe enough to pay for the gas

to get to and from the examination site.

Alternatively, do not hesitate to ask your employer or your Medical Staff to support your career growth in this way. Some may not realize that the opportunity exists and may be more than happy to help you further your career.

- **Lack of Self-Motivation** – Don't feel that you are alone in this effort. Start a study group or share studying tips. Reach out to a colleague to keep each other motivated!

Now, let's look at the benefits:

- **Personal Satisfaction – You did it!**
- **Elevation for the profession - Doing your part to raise the bar for all MSPs**
- **Promotions or new opportunities**
- **Potential for increased compensation**
- **Recognition among your peers and colleagues**
- **Being a positive example for those who report to you or work with you**

This article was intended to encourage you to consider sitting for one, or both, examinations. Yvette's recent presentation shared the details about registering for the exam, exam contents and requirements.
